

Crosswalk Between NIST AI Risk Management Framework: Generative AI Profile (AI 600-1) and Singapore / IMDA AI Verify Testing Framework

The National Institute of Standards and Technology's (NIST) *Artificial Intelligence Risk Management Framework (AI RMF): Generative Artificial Intelligence Profile*¹ aims to assist organizations in managing risks unique to or augmented by generative AI (where "risk" encompasses both benefits and harms). The Profile suggests actions to help organizations govern, map, measure, and manage these risks.

The Singapore Infocomm Media Development Authority's (IMDA) AI Verify testing framework² aims to help companies be more transparent about their AI systems, building trust through standardized tests and strengthening organizational processes. It covers 11 globally recognised principles for the risks of both traditional and generative AI.

The table below presents mappings between NIST's Generative AI Profile and IMDA's AI Verify testing framework. These mappings constitute a crosswalk analysis between the frameworks, supporting organisations in aligning their AI work with U.S. and Singapore recommendations. The mappings are color-coded by AI RMF function.
